



Four Kids' Farms, LLC 2 Year Health Warranty

1. FKF guarantees the puppy is in good health (excludes any intestinal parasites). FKF guarantees the puppy has been vet checked, had all age appropriate vaccines, dewormed and microchipped.

2. FKF provides a warranty against any debilitating congenital defects for up to 2 years after date of purchase. Debilitating congenital defects are conditions that are life threatening and have been present since birth.

-Any defect must be confirmed by a licensed vet (a necropsy will needed to be performed at buyer's expense if the dog dies)

-The buyer has to share documents with the seller within 24 hours after diagnosis.

-FKF reserves the right to request a second opinion with the vet of FKF's preference.

-If a necropsy is done and the results show an inconclusive diagnosis, warranty will be null and void.

-If the defect is determined during the warranty, the buyer will be offered a replacement puppy of equal or lower value from the next available litter at the discretion of the seller. That includes both color and gender.

-If the puppy is euthanized before a second opinion is done, warranty is null and void.

3. Warranty does not cover

-viral illnesses

-infections

-improper bites

-stress related illness

-hernias

-hypoglycemia

-parasites (includes Giardia or Coccidiosis)

-cancer

-endocrine chemicals

-physical injuries

4. FKF does not guarantee hips or elbows.

5. FKF makes a logical guess on adult weights and shedding. FKF cannot guarantee them or adult colors or hair types.

6. It is clearly understood that FKF does not take responsibility for any vet expenses. Once the puppy leaves the seller, the buyer accepts all responsibility.

7. The Buyer understands the puppy is to be examined by a licensed vet within 3 days of leaving FKF.

-If the puppy is in bad health, with proper records from the vet, the buyer can return the dog with full refund except the nonrefundable reservation fee.

-If the puppy is not taken to the vet within 3 days after leaving FKF, the warranty is null and void.

-It is asked by the seller to keep the dog contained until at least after the first 3 shots to prevent any and all illnesses.

8. The Buyer is responsible for all medical expenses associated with treating intestinal parasites if the puppy is diagnosed. This is included even if the puppy has parasites when they are sent home. Sometimes puppy parasites will flare up after joining their new family due to stress and new conditions. At times, more than one treatment is needed. The Buyer agrees to treat the puppy according to a licensed veterinarian.

9. Buyer agrees to give puppy the best life which includes, but not limited to:

1. Maintaining a healthy weight

2. Providing proper housing

3. Having the puppy seen annually and up to date on vaccinations

4. Taking the puppy to the vet when sick

5. Registering the microchip

10. Buyer agrees to never place the puppy in a shelter, pound or any facility that may be similar.

If any of this is not done, warranty is null and void.

FKF suggests obedience training within the first year. Staying away from strenuous exercises to prevent any health problems.

Buyer agrees to let FKF use any pictures to promote FKF.

Spay/Neuter needs to be done by 12 months of age. When this is done, the seller needs to forward paperwork from the vet showing that the spay/neuter has been done. If FKF does not receive paperwork, warranty is null and void.

This puppy is not sold for breeding. It is sold strictly as a pet with no breeding rights.

If the terms of this contract are not met, the warranty is null and void. Should the Buyer choose to pursue matters in the court of law, the place of jurisdiction is Edgecombe County, NC. The buyer will be responsible for any and all lawyer fees and court costs.
